What is PRINCE2®?

PRINCE2® stands for Projects IN Controlled Environments and is a widely used project management method providing all the essentials for running a successful project. It is a standard globally recognised and used by the UK government, private sector, and internationally. PRINCE2® sets out best practice in project management and is a flexible method aimed at all types of projects.

E Learning

You can now do the PRINCE2® E Learning course from the comfort of your own home at your own pace, with up to 12-months to complete. E learning allows you to interact with videos, quizzes and course content. Pre-recorded Modules are delivered by PRINCE2® practitioners. The course tracker allows you to monitor your quiz attempt's and progress. The great thing about E learning is that you can revisit material at your own pace. Once you are ready you will receive an exam voucher to attempt an online exam.

Course Content

The **PRINCE2** method addresses project management with four integrated elements of principles, themes, processes and the project environment:

The Principles

These are the guiding obligations and good practices which determine whether the project is genuinely being managed using PRINCE2. There are seven principles and unless all of them are applied, it is not a PRINCE2 project.

The Themes

These describe aspects of project management that must be addressed continually and in parallel throughout the project. The seven themes explain the specific treatment required by PRINCE2 for various project management disciplines and why they are necessary.

The Processes

These describe a step-wise progression through the project lifecycle, from getting started to project closure. Each process provides checklists of recommended activities, products and related responsibilities.

Tailoring PRINCE2 to the Project Environment

This addresses the need to tailor PRINCE2 to the specific context of the project. PRINCE2 is not a 'one size fits all' solution; it is a flexible framework that can readily be tailored to any type or size of project.

PRINCE2® Content

The course content is composed of **7 themes, 7 principles and 7 processes** and is based on a published textbook 'Managing successful projects with PRINCE2®'.



Prince2® Practitioner

Duration: 4 weeks

Options: E-learning only **or** E-Learning + Live Online Classroom

At Practitioner level, you'll cover more about how PRINCE2® can be customised to fit a project's specific requirements.

The purpose of the Practitioner level qualification is to demonstrate you have gained knowledge how to apply and tailor PRINCE2® in different situation scenarios. A successful Practitioner will know how to apply the method to various projects in one given situation but not necessarily all situations. The success of the Practitioner will depend on their individual project management expertise, complexity of the project and support provided for the use of PRINCE2® in their work environment

Eligibility criteria:

Suitable candidates must have recently completed the PRINCE2® Foundation, based on the "Managing Successful Projects with PRINCE2®" - 2017 Edition. If your PRINCE2® Foundation Certification pre-dates the 2017 version, you will need to re-enrol on the PRINCE2® Foundation course, but will not need to do the Foundation exam.

Completing pre-course reading supplied by CMI is necessary before you can progress to do the PRINCE2® Practitioner exam. You will learn to apply the 7 principles, themes, and processes to a case study. This is part of your exam and an official Axelos case study is provided.



By the end of the PRINCE2® practitioner course, you will be able to:

- Understand the characteristics and context of a project from the roles, products, principles, themes, techniques and processes
- Apply the principles, themes, and processes to a case study project (official Axelos approved case study)
- Practise exam technique and exam preparation

PRINCE2® Foundation level

The Foundation qualification is a pre-requisite for the Practitioner examination.

Exam Format

- 60minute exam duration
- 60 questions
- Closed book

33/60 required to pass = 55% pass mark



PRINCE2® Practitioner level Exams

Exam format

- 150-minute exam duration
- 68 questions
- Open book exam (official PRINCE2 manual only)

38/68 required to pass = 55% pass mark
